The Trust shall be Public Charitable Trust known as Geetha Bhavan Trust Angamaly hereinafter called the Trust. Land and other property that may hereafter be collected or received by way of donation, Bequest or otherwise for the purpose of the Trust all income, profits and gains arising to the Trust and all investments in any kind of property made by the Trust and all income arising therefrom (all of which shall become part of the Trust property of Trust Fund as the case may be) shall be vested in and held in Trust and applied for all or any of the charitable T.R. Sankara Narayana Menon Sd/- .3/- ---: 3 :-- purposes set out below in accordance with the provisions and directions herein contained.

2. The aims and objects of the Trust are:

- (a) to establish, maintain, develop, improve and make grants and donations to and to aid assist in the establishment of (a) institutions for spreading the faith in god, the consciousness of the basic identity of the supreme spirit concerned in all religions, the spirit of religious tolerance and universal brotherhood (b) educational institutions of any kind either general or ~~particular~~ <sup>Educational</sup> (c) Hostels, Boarding houses and camps for students, teachers and other connected with the institutions and establishments maintained by the trust (d) Libraries and Reading Rooms and other institutions for general or mass T.R. Sankara



a) Narayana Menon Sd/- ... 4 :-- education (e) Hospitals, Vaidyashala, Dispensaries, Nursing Homes, Medical Research Centres, Health Centres, Sanatoria and other institutions for Medical relief (ii) To organise seminars and Exhibitions, to conduct lectures and classes and publish books, pamphlets, periodicals and papers conducive to the above purpose (iii) To award scholarships and give other financial aids or loans to deserving students of Educational Institutions in India as well as for students going for studies abroad (iv) To establish printing press for printing and publication for the above purposes (v) To establish, maintain, develop, acquire take over or manage institutions or establishments having object for objects similar to those of the Trust. 3. Membership: a) There shall be four classes of members i) Founder members being the authors of the Trust. Founder members are contributed Rs. 250 each and now total Assets of the Trust is Rs. 3250/- (Rupees two thousand two hundred and fifty only). ii) Life members: Those who make a contribution of Rs. 10,000/- (Rupees ten thousand only) shall be life members of the Trust provided that the life members on the Register of Life members of the Trust as today shall continue to be life members without payment of additional contributions. iii) Honorary Members: The Board of Trustees may from time to time invite persons who have made significant contribution to the working of the Trust or who are in a/T.H. Sankara Narayana Menon Sd/- ... 5 :-- position to make such significant contributions to be honorary members. iv) Institutional Members: Corporate or other institutions which pay subscription not less than Rs. 25,000/- (Rupees twenty five thousand only) can be admitted by the Board of Trustees (as institutional members of the Trust. The Board of Trustees shall have the full power to accept or reject the application for membership from any person or institution such decisions of the Board of Trustees shall be final. 4. The management of the Trust will be in the hands of the Board of Trustees. The Board of Trustees shall have powers: a) to raise funds by accepting grants, donations or otherwise. b) to create assets by purchase, lease or otherwise c) to enter into real property transactions to further the interest of the Trust. d) to open and operate Bank accounts of the Trust. e) To accept or grant loans on behalf of the Trust. f) To employ personnel for the working of the Trust and to determine the terms and conditions, of such employment. g) To invest Trust funds in stocks, shares, securities, land, buildings or otherwise in the best interest of the Trust. h) To do all such acts and things as are necessary and conducive to the best interest of the Trust. 5. Board of Trustees: The Board of Trustees shall consists of not less than six and not more than nine members. b) The following founder members shall be members of the Board of Trust for life. The Board of Trustees may at their discretion nominate a person from among the trustees as the patron of the trust. The first patron shall be Sri P. Parameswaran Nambooripad. e) In the event of vacancy in the Board of Trustees due to death, resignation or otherwise, Trustees shall be nominated by the Board of Trustees. One third of the trustees shall retire at the end of 3rd year on the basis of first-come-first-go. They shall be eligible for re-nomination. In case of a tie the retirement will be decided by lot. f) No person shall be eligible to be elected as a Trustee if he has any of the disqualifications prescribed in the Indian Companies Act. A person shall cease to be a member of the Board of Trustees, the moment he becomes disqualified as per the Companies Act. T.R.Sankara Narayana Menon 5d/- ....7/- --; 7 :-- 6. Managing Trustees: a) The Managing Trustee shall be responsible for the day to day management of the affairs of the Trust subject to the overall policy and supervision of the Board of Trustees. b) He shall have full disciplinary powers over all the employees of the Trust and will be the appointing and dismissing authority. c) The Bank accounts and funds of the Trust shall be operated subject to such regulations as may be prescribed by the Board. d) He shall also exercise such special powers as are delegated to him by the Board. e) He shall be the custodian of all assets and documents of the Trust and may be authorised to execute all agreements, contracts and other documents and to raise loans on behalf of the Trust. f) He shall be responsible to ensure that Trust meetings are held regularly, the minutes are kept properly and the decisions of the Trust implemented promptly and faithfully and shall be deemed to hold the General Power of attorney of the trust. g) To preside over the meetings of the Board of Trustees and the annual general body meetings. 7. Annual General Body Meeting: a) The Annual General Body Meeting of the Trust shall ordinarily be held between July and September every year. b) The General Body of the Trust shall consist of i) All Life members ii) All Honorary Members. ... iii) All the institutional members. iv) All members of the Board of Trustees. c) 21 days' notice shall be given for the Annual General Body Meeting. d) The following business are to be transacted at the annual general body meeting. i) Presentation of the Annual report and statements of accounts by the Board of Trustees. ii) Nomination of Trustees to vacancies available. iii) Appoint of Auditors. iv) Amendment to Bye-laws.

6. Extra ordinary General Body Meetings: a) An extra ordinary general body meeting may be convened at any time by i) The Managing Trustee ii) The Board of Trustees iii) Not less than one third of the life members on the rolls of the Trust for transacting a specific item of business. b) Such meeting shall require 14 days' notice. c) Such meeting shall not transact any business other than the one for which it has been convened.

7. Meetings General Quorum: a) General Body Meetings: All decisions will be taken on the basis of simple majority vote. In the case of tie the Chairman shall have a casting vote. b) Board of Trustees: All decision will be taken on the basis of a simple majority vote. In the case of tie the Chairman shall have a casting vote, T.R. Sankara Narayana Menon Sd/- ...9/- --: 9 :-- c) Quorum for the General Body will be 10 for the Board of Trustees the Quorum will be four.

10. Casual Vacancies may be filled up in the manner prescribed under rule 5 above.

11. General: i) This is a Charitable Trust. No member of the Trust or Board of Trustees shall be eligible for any remuneration for any services rendered. This does not prevent any member being reimbursed out of pocket expenses incurred by them on behalf of the Trust. ii) The beneficiaries of the Trust are not restricted to any particular religion or community. iii) No act of the Board of Trustees will be invalid merely because of the existence of an unfilled vacancy, or any irregularity or defect in the co-option of a successor Trustee.

12. Amendment to Bye-laws: The following procedure should be observed for amending the bye-laws: a) Amendments will be made only at the annual General Body Meeting or at Extra Ordinary General Body Meetings specially convened for the purpose. b) The amendments whenever proposed should be got approved by the Board of Trustees on the first instance. c) The proposals can be circulated only by the Managing Trustee and not by any individual or group of members. T.R. Sankara Narayana Menon Sd/- ...10/- --: 10 :-- d) The amendment (whenever proposed) will be treated as passed if approved by more than one half of the life members of the Trust on the Rolls at the time of 2/3 of the members present at the meetings and eligible to vote.

13. Dissolution of the Trust: In the event of the extinction of the Trust, the properties and other assets of the Trust shall be handed over to a charitable trust or institution having objects similar to those laid in this deed.
